### COMMITMENT

1. We hereby invest authority in the school to discipline our child when necessary as outlined in the Parent-Student Handbook. We further agree that we will cooperate and discipline our child in the home as needed.(Proverbs 13:24, 19:18, 22:6, 23:13-14; Ephesians 6:1-2; Colossians 3:20; Hebrews 12:6)
2. We pledge our fullest cooperation to keep doctrinal controversy and denominationalism out of the school at all times. (Romans 13:8-10; 1 Corinthians 12:12-14, 13:1-13; Galatians 5:13-15, 25 & 26; Ephesians 4:1-7)
3. We agree that, should there be questions about, or disagreement with, school policy or procedures, we will in no case complain to any parent but, in the love of Christ and with prayer, we will register only necessary complaints with the teacher or administrator, as appropriate.
4. We understand that assessments will be made to cover damage to school property; e.g., breakage of windows, abuse of books, etc.
5. We agree to pay tuition according to the current payment schedule and to conclude all payments on or before the last day of school, or report cards will be withheld. We understand that Board policy states that all installment or monthly accounts are to be paid by the 1<sup>st</sup> of each month. After the 10<sup>th</sup> a late fee is added. Also, that when the account becomes 30 days overdue, student(s) will not be permitted to attend class, unless special arrangements are made with the bookkeeper.
6. We agree that any claim or dispute arising out of, or related to, this agreement or to any aspect of the school relationship, including any claim or statutory claims, shall be settled by Biblically based mediation as outlined in the Parent-Student Handbook, following the current principles and procedures of the Institute for Christian Conciliation. (1 Corinthians 6:1-8; Matthew 5:23-24, 18:15-20)
